4.1 Description of first aid measures

Following inhalation

Following skin contact

After contact with skin, take off immediately all contaminated clothing, and wash immediately with plenty of water. If skin irritation persists: Get medical advice/attention.

Following eye contact

Remove contact lenses, if present and easy to do. Irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart. Seek medical attention.

Following ingestion

Keep at rest. Rinse mouth with water (only if the person is conscious). Do NOT induce vomiting. Get emergency medical help immediately.

4.2 Most important symptoms and effects, both acute and delayed

Causes serious eye irritation. May cause gastrointestinal irritation, nausea, diarrhoea and vomiting. Skin contact may cause mild irritation. Inhalation of mist may cause respiratory irritation.

5.2 Special hazards arising from the substance or mixture

5.3 Advice for firefighters

7.1 Precautions for safe handling

Recommendations

- Measures to prevent fire as well as aerosol and dust generation

Use only in well-ventilated areas. Handle and open container with care.

Advice on general occupational hygiene
